I Nia Assata acknowledge that for good and valuable consideration, the receipt of which is hereby acknowledged, irrevocably authorize, Kyra Iverson Kind Hearted Images to photograph and/or film and sound record my and/or my property and furthermore grant permission to use the resulting work ("THE WORK") according to the terms stated as follows:

1. Any permissions granted to the PHOTOGRAPHER shall extend to her legal representatives, successors, assigns and licensees and shall be irrevocable and lasting without any further or additional claim for compensation by the MODEL, outside of that compensation that has already been acknowledged and received within the scope of this release agreement.
2. Use of THE WORK shall be unrestricted as to the location, quantity, or frequency, may be for any purpose and in any medium whatsoever, except where such use is in violation of the law.
3. Permission is specifically granted for THE WORK to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics, text, and sound in any way and without restrictions. Use of THE WORK may be in conjunction with the MODEL'S own or fictitious names.
4. The permission granted herein is absolute and final and shall not be subject to further inspection or approval by the MODEL at any stage in the use of THE WORK.
5. The PHOTOGRAPHER shall own all rights to THE WORK which shall accrue to the benefit of her successors, legal representatives, and assigns.
6. The MODEL must post, tag, and/or share at least one photograph of themselves taken by the PHOTOGRAPHER to a social media site of his/her choice. THE WORK that is posted, tagged, and/or shared on any social media site must always without any exception, cite the PHOTOGRAPHER and/or KIND HEARTED IMAGES as the source and owner of THE WORK.
7. It is hereby agreed by both parties, that the MODEL has permission to use THE WORK in any location, quantity, media, and frequency. The MODEL hereby agrees to abide by the following restrictions regarding his/her use of THE WORK:
 - The MODEL shall not edit, alter, distort, or use THE WORK in conjunction with other images, graphics, text, and sound in any way.
 - The MODEL must always without any exception, cite the PHOTOGRAPHER and/or KIND HEARTED IMAGES as the source and owner of THE WORK when using THE WORK in any location or media.
 - The MODEL shall not use THE WORK for advertisement and/or financial gain.
8. Both parties hereby agree that the MODEL shall receive one digital copy of all photographs taken of their person and/or property, and one free session of his/her choice (excluding Newborn, Event, or Wedding Photography Packages) as consideration for his/her modeling for the PHOTOGRAPHER.
9. The MODEL, or his/her Parent or Guardian in cases where the MODEL is a minor, hereby warrants having read and understood this Model Release Agreement and warrants being of full legal age to enter an agreement, namely 18 years of age or more.
10. With full knowledge of the above, the MODEL hereby releases and shall hold harmless the PHOTOGRAPHER, KIND HEARTED IMAGES, or its legal representatives, successors, assigns and licensees from all claims or damages including but not limited to defamation or violation of right of privacy or publicity, resulting from, or associated with the use of THE WORK.
11. The MODEL agrees that the provisions contained herein shall be binding upon the MODEL and his/her legal representatives, successors, and assigns.
12. This Agreement shall be construed, interpreted, and governed in accordance with the laws of the State of California and should any provision of this Agreement be judged by an appropriate court invalid, it shall not affect any of the remaining provisions whatsoever.
